

## **INVITATION TO BID FOR THE REPAIR FOR THE MAINTENANCE OF SIXTY-TWO (62) HOLES ON SASA WHARF CONCRETE DECK, SASA PORT AREA, DAVAO CITY**

The *Philippine Ports Authority*, through the Philippine Ports Authority Maintenance Project Funds as per NBA reference Nos. 20110874, intends to apply the sum of *Pesos: Six Million Seven Hundred Twenty Six Thousand Four Hundred Eighty Five (Php6,726,485.00)* only, being the Approved Budget for the Contract (ABC) to payments under the contract for the *Repair for the Maintenance of Sixty-Two (62) Holes on Sasa Wharf Concrete Deck, Davao City*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, Port Management Office of Davao, now invites bids for the Repair for the Maintenance of Passenger Terminal Building and Guardhouse and Passenger Covered Walkway at the Sasa Port, Davao City. Completion of the Works is required in One Hundred twenty (120) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from *PPA, PMO-Davao* and inspect the Bidding Documents at the address given below from *26 September 2011 to 24 October 2011 at 8:00AM – 5:00PM*.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Ten Thousand Pesos (Php10,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.



Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Philippine Ports Authority, Port Management Office of Davao* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
