- c. Surety Bond callable upon demand issued by the GSIS, a surety or insurance company duly accredited by the Insurance Commission or a combination thereof – Thirty Percent (30%) of the Total Contract Price.

The performance security shall remain valid until the issuance of the Final Acceptance of the Contract by the Procuring Entity.

Failure to provide the performance security on time shall constitute sufficient grounds for cancellation of the award and forfeiture of your Bid Security.

In addition, you are required to provide the original copy of the Contractor's All Risk Insurance (CARI) from the GSIS or any private insurance company duly accredited by Insurance Commission pursuant to Article XII of the provision of the draft contract agreement issued as part of the bid documents. No advance payment and progress payment shall be released if the CARI is not submitted.
