INVITATION TO BID

FOR THE PROPOSED DREDGING OF DAPITAN, ILIGAN AND CAGAYAN DE ORO PORTS, NORTHERN MINDANAO

The Philippine Ports Authority, through the Corporate Budget of the Authority for CY 2018, intends to apply the sum of **₱ 81,981,666.52** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Proposed Dredging of Dapitan, Iligan and Cagayan de Oro Ports, Northern Mindanao (LFP NOMIN No. 008-2018)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority now invites bids for **A. Dredging along berths and maneuvering areas of the Ports to a designed depth below Mean Lower Low Water (MLLW) as follows: 6.00 and 8.00m for Dapitan Port; 5.50, 8.00 and 11.00m. for Iligan Port and 11.00 and 13.00m. for Cagayan de Oro Port B. Total Volume to be dredged = 155,000 cu. m. (45,000 cu. m., 40,000 cu. m. and 70,000 cu. m., respectively) of loose to medium dense clayish soil, mud, silt and sand with possible compacted/hard materials C. Disposal of dredged soil materials 16.00 kms. away from the project site.** Completion of the Works is required in **230 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Philippine Ports Authority Bids and Awards Committee (BAC) for Engineering Projects and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m., Monday to Friday.

A complete set of Bidding Documents may be acquired by interested Bidders on 13 April 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIFTY THOUSAND PESOS (₱ 50,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Ports Authority, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids must be duly received by the BAC Secretariat at the address below on or before **9:00 a.m. of 09 May 2018**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the bidding documents.

Bid opening shall be on **09 May 2018 2017 at 10:00 a.m.** at the 7th Floor, PPA Building, A. Bonifacio Drive, South Harbor, Port Area, Manila. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The Philippine Ports Authority reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
