## INVITATION TO BID

### FOR THE PROPOSED CONSTRUCTION OF CARGO SHIP PORT, PORT OF JUBANG, DAPA, SURIGAO DEL NORTE

The Philippine Ports Authority, through the Corporate Budget of the Authority for CY 2018, intends to apply the sum of **₱ 638,125,905.79** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Proposed Construction of Cargo Ship Port, Port of Jubang, Dapa, Surigao del Norte, (LFP SUG No. 013-2018)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority now invites bids for **A. Construction of RC Wharf (Area=2,205.00 sq. m. B. Construction of RC Platform (Area=945.00 sq. m.) C. Construction of Back-up Area (Area=7,350.00 sq. m.) D. Construction of Access Road With Back-up Area (Area=5,516.79 sq. m.) E. Port Lighting System.** Completion of the Works is required in **660 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Philippine Ports Authority Bids and Awards Committee (BAC) for Engineering Projects and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m., Monday to Friday.

A complete set of Bidding Documents may be acquired by interested Bidders on **22 June 2018** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **SEVENTY FIVE THOUSAND PESOS (₱ 75,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Ports Authority, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids must be duly received by the BAC Secretariat at the address below on or before **9:00 a.m. of 18 July 2018**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the bidding documents.

Bid opening shall be on **18 July 2018 at 10:00 a.m.** at the 7<sup>th</sup> Floor, PPA Building, A. Bonifacio Drive, South Harbor, Port Area, Manila. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.


