**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROPOSED RENOVATION OF PPA EXECUTIVE LOUNGE AND GYM, PPA
CORPORATE BUILDING, SOUTH HARBOR, PORT AREA, MANILA
LFP NCS NO. 058-2018**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Renovation of PPA Executive Lounge and Gym, PPA Corporate Building, South Harbor, Port Area, Manila, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 21 December 2018, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₱ 6,766,127.12**;

WHEREAS, in response to the said advertisement, two (2) prospective bidders secured the Bid Documents in the amount of ₱ 10,000.00, namely:

1. Ayson P.D. Construction
2. NOE's Builders

WHEREAS, only Ayson P.D. Const. dropped its Technical and Financial Proposals in the bid boxes located at the BAC Office, 5th Floor, PPA Building, while NOE's Builders submitted its bid documents at 9:55 a.m. or after the prescribed deadline of 9:00 a.m., hence the same were not accepted by the BAC Secretariat, pursuant to the 2016 Revised IRR of R.A. 9184 on late submission of bids.

WHEREAS, during the opening of bids on 25 January 2019 at 10:30 a.m., Ayson P.D. Const. was automatically disqualified for failure to comply with the requirements that the Bid Proposals should be book-bound and hard-bound, and with index tabs, as required in the Bid Data Sheet and pointed out in the Important Reminders for the Pre-Bid Conference.

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Proposed Renovation of PPA Executive Lounge and Gym, PPA Corporate Building, South Harbor, Port Area, Manila, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

- b) All prospective bidders are declared ineligible;

XXX XXX XXX.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Proposed Renovation of PPA Executive Lounge and Gym, PPA Corporate Building, South Harbor, Port Area, Manila, be declared a "failure for the second time," pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. Subject to the instructions/recommendation of the Head of the Procuring Entity, to conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184 or resort to Alternative Method of Procurement through Negotiated Procurement (two failed biddings).
