WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation To Bid for the Proposed Construction and Offshore Installation of Aids to Marine Navigation at Ports of Tagbilaran, Tubigon, Tapal and Jagna, Bohol (Phase I), Bohol Province, in the Manila Standard, a newspaper of general nationwide circulation on 22 November 2017 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₱ 330,216,066.04**;

WHEREAS, in response to the said advertisement, only Goldridge Const. and Dev't. Corp./Dalebo Const. and Gen. Merchandise/Jarzoe Builders, Inc./JV secured and submitted the Bid Documents in the amount of **₱ 50,000.00**;

WHEREAS, during the opening of bids on 19 December 2017 at 2:00 p.m., Goldridge Const. and Dev't. Corp./Dalebo Const. and Gen. Merchandise/Jarzoe Builders, Inc./JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Goldridge Const. and Dev't. Corp./Dalebo Const. and Gen. Merchandise/Jarzoe Builders, Inc./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 22 December 2017 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 27 December 2017, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Goldridge Const. and Dev't. Corp./Dalebo Const. and Gen. Merchandise/Jarzoe Builders, Inc./JV;

WHEREAS, Goldridge Const. and Dev't. Corp./Dalebo Const. and Gen. Merchandise/Jarzoe Builders, Inc./JV was declared as the Single Calculated Bidder in the amount of ₱ 328,983,990.44, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, post-qualification was conducted on 28 December 2017 to examine, validate and verify the eligibility, technical and financial requirements submitted by Goldridge Const. and Dev't. Corp./Dalebo Const. and Gen. Merchandise/Jarzoe Builders, Inc./JV and in the Post-Qualification Report, as approved by the BAC on 10 January 2018, Goldridge Const. and Dev't. Corp./Dalebo Const. and Gen. Merchandise and Jarzoe Builders, Inc./JV was declared as the Single Calculated and Responsive Bidder;
