WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₱ 10,266,147.98**;

WHEREAS, in response to the said advertisement, only KRBS Const. and Trading secured and submitted the Bid Documents in the amount of **₱ 25,000.00**;

WHEREAS, during the opening of bids on 21 May 2018 at 11:00 a.m., KRBS Const. and Trading was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of KRBS Const. and Trading was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:
