

**SUPPLEMENTAL AGREEMENT TO THE CONTRACT FOR THE PROVISION  
OF TECHNICAL AND ADMINISTRATIVE SUPPORT MANPOWER  
SERVICES FOR PPA HEAD OFFICE RESPONSIBILITY CENTERS AND PROJECTS FOR CY 2017  
(Contract Extension)**

KNOW ALL MEN BY THESE PRESENTS:

This Supplemental Agreement to the Contract for the Provision of Technical and Administrative Support Manpower Services for the PPA Head Office Responsibility Centers and Projects for CY 2017, is made and entered into this FEB 10 of 2019 2019, by and between:

**PHILIPPINE PORTS AUTHORITY**, a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, and hereinafter referred to as the "**PPA**"

-and-

**LBP SERVICE CORPORATION** ( TIN No. 004- 983-987-000), a private corporation organized and existing in accordance with Philippine laws, with principal office address at units C & D 21<sup>st</sup> Floor, Petron Mega Plaza Bldg. Sen. Gil Puyat Ave, Makati City, represented herein by its Executive Vice President – Business Operations Group, **JOSEPH V. ANGELES**, as evidenced by Secretary's Certificate a copy of which is hereto attached and made integral part hereof as Annex "A" and hereinafter referred to as the "**CONTRACTOR**".

**WITNESSETH:**

WHEREAS, a Contract for the Provision of Technical and Administrative Support Manpower Services for PPA Head Office 2017 (herein referred to as the " Original Contract") with a duration from December 16, 2017 to December 15, 2018, was executed by and between the herein parties on December 12, 2017 and entered in the Notarial Register of Atty, Virgilio R. Batalla as Doc. No. 387, Page No. 79, Book No. 216, Series of 2017, a copy of which is hereto attached as Annex "B", and made integral part hereof;

WHEREAS, pursuant to Government Procurement Policy Board (GPPB) Resolution No. 23 – 2007, dated September 28, 2007, as amended, procuring entities may extend the duration of on-going contracts about to expire for a period not exceeding one (1) year as an emergency measure to maintain the status quo in the operations of the Procuring Entity and to avoid interruption of service until the completion of procurement activities.

WHEREAS, the Original Contract has expired on December 15, 2018, and to avoid interruption of service, the General Manager approved the extension of the Original Contract for three months or from December 16, 2018 to March 15, 2019, a copy of Supplemental Agreement is hereto attached as Annex "C" and made an integral part hereof;

2. CONSIDERATION – In full consideration of the service rendered, the PPA shall pay the Contractor under the same terms and conditions as provided for in the original contract.
3. PERFORMANCE SECURITY – The Contractor shall post and submit to PPA an additional Performance Security in the form and schedule as provided in the original contract.
4. APPLICABILITY OF THE PROVISIONS OF THE ORIGINAL CONTRACT – The terms and conditions of the Original Contract shall remain valid and subsisting except as amended by or inconsistent with this Supplemental Agreement.


