AMENDMENT TO THE APPLICATION OF THE REVISED FIXED FEE AND THE FIXED FEE/VARIABLE FEE POLICIES IN THE IMPOSITION OF GOVERNMENT SHARE/PPA SHARE FROM

CARGO HANDLING OPERATORS/CONTRACTORS

### OBJECTIVE:

1mplementation Pixed 2 1 To harmonize the of the Fee/Variable Fee and Revised Fixed Fee schemes and percentage share system as reasonable mode of sharing between PPA and the cargo handling operators in the grant of the privileges to the latter to manage and operate cargohandling related services

#### 3 **PURPOSE**

To provide guidelines in the implementation of the said Fixed Fee/Variable Fee, Revised Fixed Fee and Percentage Fee schemes

#### SCOPE 4

4 1 This Administrative Order shall apply to existing cargo handling contractors/operators in all government ports, whose contracts with PPA stipulate the payment of Fixed/Variable Fee/Revised Fixed Fee and contractors who will be issued contracts containing stipulation on the Revised Fixed Fee

### 5. GUIDELINES:

- Fee in contracts that will be issued and for existing contracts with Fixed Fee/Variable Fee and Revised Fixed Fee shall likewise continue in the imposition of government share from their cargo handling and related services income, provided that in no case shall the government share be less than ten (10%) percent of the gross revenue in any given year of the contract involving purely domestic cargo handling service and not less than twenty (20%) percent of the gross revenue for foreign cargo handling service.
- 5.2 If the Fixed Fee/Variable Fee and the Revised Fixed Fee stipulated in the existing contracts of cargo handling operators are found in any given contract year to be less than ten (10%) percent of the gross revenue from cargo handling and related services on domestic cargoes and less than twenty (20%) of the gross revenue from cargo handling services on foreign cargoes, the difference between the actual remittance and the computed 10% or 20% as the case may be, shall be paid by the operator/contractor concerned
- 5.3 The PMO shall strictly monitor remittances made by all contractors/operators within its jurisdiction and shall conduct periodic audit on the financial aspect, among others, of the operators/contractors concerned in coordination with the PDO-Internal Control Staff and Internal Control Department at the Head Office

### 5. AMENDATORY CLAUSE

5.1 Any provisions of existing guidelines and rules and regulations which are contrary to or inconsistent herewith shall be deemed amended or accordingly modified

### 6 EFFECTIVITY

6 1 This Administrative Order shall, after approval by the Board of Directors of the Authority, take effect fifteen (15) days after publication in a newspaper of general circulation
