SUBJECT : INCLUSION OF THE PORTS OF MAUBAN AND PAGBILAO
UNDER THE SIAIN-HONDAGUA-CASIGURAN PILOTAGE
DISTRICT

1. AUTHORITY

- 1.1 Section 6-a (viii) of P.D. 857
- 1.2 Section 6, Article II of PPA AO No. 03-85

2. SCOPE

This Order shall cover all vessels calling at the Ports of Mauban and Pagbilao, Province of Quezon.

3. OBJECTIVE

To designate the Ports of Mauban and Pagbilao under the Siain-Hondagua-Casiguran Pilotage District in view of their proximity to said District.

4. GUIDELINES

4.1 Jurisdictional Area of Siain-Hondagua-Casiguran Pilotage District

Paragraph 21 (Siain-Hondagua-Casiguran Pilotage District) of Annex "A" to Section 6, Article II of PPA AO No. 03-85 is hereby modified to read as follows:

"21. Siain-Hondagua-Casiguran Pilotage District

Shall embrace all the waters along the coast of Eastern Luzon bounded by a line drawn from Lat. 14° 14.'2 N - Long. 121° 55.'8 E (Gerardo Point on Jomalig Island) to Lat. 14° 30.'0 N - Long. 122° 30.'0 E thence to Lat. 16° 01.'7 N - Long. 121° 59.'3 E (Cape San Ildefonso) including the ports and harbors of Siain-Hondagua Lat. 13° 56.'8 N - Long. 122° 14.'5 E, Baler Lat. 15° 45.'9 N - Long. 121° 33.'8 E, Casiguran Lat. 16° 15.'0 N - Long. 122° 07.'3 E, and the Polillo Islands Lat. 14° 43.'0 N - Long. 121° 56.'2 E, AND

SHALL, LIKEWISE, EMBRACE ALL THE WATERS ALONG THE COASTS OF MAUBAN LAT. 14° 12' 22" N - LONG. 121° 45' 07" E AND PAGBILAO LAT. 13° 58' 30" N - LONG. 121° 41' 30" E."

4.2 Pilots' Boarding Station

Pending the establishment of a pilots' boarding station at the Ports of Mauban and Pagbilao, a safe distance of not less than one (1) nautical mile from the port or anchorage shall be the interim pilots' boarding station.

4.3 Establishment of a Pilotage Office

The Pilotage Association concerned shall be required to put up an office at Plaridel (Siain) in order to provide timely pilotage services and limit transportation cost by the pilots on duty.

6. REPEALING CLAUSE

All PPA orders, rules and regulations, circulars and memoranda which are inconsistent with this Order are hereby repealed or modified accordingly.

7. EFFECTIVITY

This Order shall take effect fifteen (15) days after publication in any newspaper of general circulation.
