CREATION OF PHILIPPINE PORTS AUTHORITY-PASSENGER TERMINAL BUILDING - SAN ISIDRO PORT SERVICES (PPA-PTB-SIPS) FOR THE MANAGEMENT, OPERATION AND MAINTENANCE OF THE PTB SERVICES AT THE PORT OF SAN ISIDRO, NORTHERN SAMAR

In the exercise of the mandate of PPA to manage, operate, develop and maintain the port under its administrative jurisdiction, and to ensure continuous and efficient delivery of PTB services as prescribed by Presidential Decree No. 857, as amended, the PPA-Passenger Terminal Building-San Isidro Port Services (PPA-PTB-SIPS) Is hereby created.

The PPA-PTB-SIPS shall henceforth manage, operate and maintain the PTB services at the Port of San Isidro, with powers, functions and duties as may be necessary to enable it to carry out its purposes, subject to the following guidelines:

- 1. Ensure the continuous and uninterrupted PTB services in a more efficient manner:
- Utilize the present labor force of the incumbent PTB Operator under the same terms and conditions prevailing at the time of the effectivity of this Order and observe all labor laws, rules and regulations;
- 3. Collect the existing PTB Fees, rental rates and other charges for PTB services rendered:
- 4. Disburse funds to finance the necessary expenses of operations in accordance with the systems prescribed by the PPA;
- 5. Conduct inventory of properties still in the custody of the PTB Operator as of takeover date;
- 6. Conduct inventory of PTB records:
- 7. Conduct inventory of unused forms and supplies which can be used for the takeover;
- 8. Conduct inventory of office and field personnel; and

9. Submit monthly operational and financial reports to the Assistant General Manager for Operations.
