PPA MEMORANDUM ORDER

SUBJECT: Revocation of PPA Administrative Order (AO) No. 09-2021

entitled "Grant of 50% Discount on Waste Reception Fee for Motor bancas and Passenger/Cargo Vessels with Capacity of More Than 15 Passengers and Up to 35 Gross Tonnage (GT) During the State of National Emergency Due to COVID-19

Pandemic"

In view of the Proclamation No. 297 issued by the President of the Philippines lifting the state of public health emergency throughout the Philippines due to COVID-19, PPA AO No. 09-2021, otherwise known as "Grant of 50% Discount on Waste Reception Fee for Motor bancas and Passenger/Cargo Vessels with Capacity of More Than 15 Passengers and Up to 35 Gross Tonnage During the State of National Emergency Due to COVID-19 Pandemic" is hereby revoked.

As such, all Port Management Offices (PMOs) shall have ceased the granting of the 50% discount on Waste Reception Fee (WRF) for motor bancas and passenger/cargo vessels with capacity of more than 15 passengers and up to 35 GT operating in the domestic trade and calling at all ports under the jurisdiction of PPA.

Further, using the attached sample format, the PMOs shall submit a report to the Office of the General Manager, Attention: CSD, on November 6, 2023, on the total foregone revenue share because of the granting of the 50% discount on WRF commencing December 21, 2021, the effectivity of PPA AO No. 09-2021, until the lifting of the Presidential Proclamation No. 222. S. 2020 through Proclamation No. 297 by the President of the Philippines on July 21, 2023.

All previous orders and issuances inconsistent herewith shall be deemed revoked.

This Order shall take effect immediately.
