SUBJECT : REVOCATION OF PPA OPERATIONS MEMORANDUM ORDER (OMO) NO. 01-2022 – “INTERIM GUIDELINES ON PPA ACCREDITATION AND PERMIT TO OPERATE (PTO)”

Pursuant to PPA Board Resolution No. 3185 and consistent with the objective of implementing simplified procedures and documentary requirements for port service providers to be able to transact inside the port and at the same time ensure credibility thereof thus upholding port safety and security, PPA OMO No. 01-2022, otherwise known as “Interim Guidelines on PPA Accreditation and Permit-To-Operate (PTO)” is hereby revoked.

As such, applications for PPA Accreditation and PTO shall be processed in accordance with PPA Administrative Order (AO) No. 06-2019 - “Guidelines on the Accreditation of Port Service Providers” and PPA AO No. 09-2020 – “Revised Guidelines on the Issuance of Permit to Operate (PTO) for the Provision of Ancillary Service in the Ports”, respectively.

Further, the Transport Accreditation, Permit and Access Pass for Ports (TAPPP) pursuant to PPA AO No. 01-2022 – “Omnibus Guidelines on the Accreditation, Permit and Pass for Transport Service Providers in Ports” shall continue to be implemented.

The ICTD shall immediately activate operation of online systems pertinent to this Order.

This directive is to facilitate and ensure uninterrupted day-to-day provision of cargo handling, logistics and other services in ports consistent with the thrust of the Department of Transportation to improve the port industry for the benefit passengers and shippers.

All previous orders and issuances inconsistent herewith shall be deemed revoked or amended accordingly.

This Order shall take effect immediately.
