TERMS OF REFERENCE

A. BACKGROUND

The Philippine Ports Authority, PMO Palawan, in line with its property and asset management program wherein unserviceable, no longer needed and/or obsolete equipment, furniture and fixtures are sold, destroyed, donated or transferred to another government agency or institution, is conducting disposal through public auction of two (2) lots unserviceable properties, one (1) lot from the reported physical count of Property, Plant and Equipment (PPE) of PMO Palawan as of December 31, 2014, and the other lot are semi-expendable materials. These were issued an authority to dispose in a memorandum of the General Manager dated December 10, 2015.

B. OBJECTIVE

There is a need for the disposal of the above-mentioned unserviceable properties to avoid further deterioration as well as to generate greater benefits to the government in terms of higher appraisal value, lesser storage cost and better management of limited space for unserviceable properties/assets.
