



INVITATION TO BID

FOR THE:

REPAIR OF SIDEWALK AT SH EXPANDED PORT ZONE, PORT AREA, MANILA

The Philippine Ports Authority, PMO-NCR South, through the Corporate Budget of the Authority for CY 2021, intends to apply the sum of **₱ 22,770,964.89** being the Approved Budget for the Contract (ABC) to payments under the contract for the **REPAIR OF SIDEWALK AND LIGHTING SYSTEM AT SH EXPANDED PORT ZONE, PORT AREA, MANILA (PMO-NCR South-A210034)**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

The Philippine Ports Authority now invites bids for the following Scope of Works:

1. GENERAL EXPENSES
2. PAVING BLOCKS
3. CURB AND GUTTER
4. ROAD STUDS (Solar)
5. SOLAR LIGHT PEDESTAL (Existing Concrete Pedestal)

Completion of the Works is required in **NINETY-TWO (92) CALENDAR DAYS**. Bidders should have an experience of having completed at least one (1) contract that is similar to the contract to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

All bids must be accompanied by a bid security in any of the acceptable form and in amount stated in ITB Clause 16.


