



INVITATION TO BID

FOR THE REPLACEMENT OF DILAPIDATED WINDOWS, VINYL TILES, PVC DOOR AND CONCRETING OF DEPRESSED ERODED FILL AT VTSD CONTROL CENTER, MICT, TONDO, MANILA

The Philippine Ports Authority, PMO-NCR North, through the Corporate Budget of the Authority for CY 2019, intends to apply the sum of **P1,798,854.85** being the Approved Budget for the Contract (ABC) to payments under the contract for the Replacement of Dilapidated Windows, Vinyl Tiles, PVC Door and Concreting of Depressed/Eroded Fill at VTSD Control Center, MICT, Tondo, Manila (Contract No. PMO-NCN-A190141). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority now invites bids for **Replacement of Dilapidated Windows, Vinyl Tiles, PVC Door and Concreting of Depressed/Eroded Fill At VTSD Control Center, MICT Tondo, Manila**. Completion of works is required within **45-calendar days**. Bidder should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidder may obtain further information from the PMO-NCR North Bids and Awards Committee (PMO-NCR-NORTH-BAC) and inspect the Bidding Documents at the address given below from 8:00 a.m to 5:00 p.m., Monday to Friday.

A complete set of Bidding Documents may be acquired by interested Bidders on **November 12-December 3, 2019** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (P5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Electronic Procurement System (PhilGEPS) and the website of the Philippine Ports Authority, provided that

bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The PMO-NCR North Bids and Awards Committee will hold a **Pre-Bid Conference** on **November 19, 2019 at 10:00AM**, at the Conference Room, PMO-NCR North Administration Building, Radial Road 10, North Harbor, Tondo, Manila, which shall be open to all prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **9:30AM of December 3, 2019**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the bidding documents.

Bid opening shall be on **December 3, 2019 at 10:00AM**, at the Conference Room, PMO-NCR North Administration Building, Radial Road 10, North Harbor, Tondo, Manila.. Bids will opened in the presence of the bidder's representatives who choose to attend. Late bids shall not be accepted.
