REPAIR OF PORT FACILITIES DAMAGED BY TYPHOON OMPONG, PORT OF CURRIMAO, ILOCOS NORTE

The Philippine Ports Authority, Port Management Office of Northern Luzon (PPA PMO Northern Luzon), through the Corporate Budget of the Authority for CY 2019, intends to apply the sum **Eight Million Six Hundred Ninety Four Thousand Three Hundred Ninety Eight Pesos (Php8,694,398.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **REPAIR OF PORT FACILITIES DAMAGED BY TYPHOON OMPONG, PORT OF CURRIMAO, ILOCOS NORTE**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

PPA PMO Northern Luzon now invites bids for the **REPAIR OF PORT FACILITIES DAMAGED BY TYPHOON OMPONG, PORT OF CURRIMAO, ILOCOS NORTE** with the following scope of works:

Completion of the Works is required in **Ninety (90) Calendar Days**. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Implementing Rules and Regulations (IRR) of Republic Act 9184 (R. A. 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Bids and Awards Committee, PPA PMO Northern Luzon and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested Bidders on November 12 to December 2, 2019 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Ten Thousand (Php10,000.00) Pesos**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Ports Authority, provided that the bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The PPA PMO-Northern Luzon Bids and Awards Committee will hold a Pre-Bid Conference on **November 19, 2019, Tuesday, 10:00AM** at the Conference Room, PMO Northern Luzon, Poro, San Fernando City, La Union, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **December 2, 2019, Monday at 10:00AM**. All bids must be accompanied by a Bid Security in any of the acceptable forms and the amount stated in ITB Clause 18.

Bid opening shall be on **December 2, 2019, Monday at 3:00PM** at PPA PMO-Northern Luzon Conference Room. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

Required PCAB Registration: **SMALL B – "PORTS, HARBOR & OFFSHORE ENGINEERING"**

The Philippine Ports Authority, PMO Northern Luzon reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected Bidder or Bidders.
