

Invitation to Bid for the

Repair of Damages caused by Typhoon Odette at Ports of Puerto Princesa, Coron and Cuyo, Palawan (MPF-PLW-01-2022)

- The Philippine Ports Authority PMO Palawan, through the Corporate Budget of the Authority for CY 2022 intends to apply the sum of Php/ 1,725,172.02 being the Approved Budget for the Contract (ABC) to payments under the contract for Repair of Damages caused by Typhoon Odette at Ports of Puerto Princesa, Coron and Cuyo, Palawan. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Philippine Ports Authority PMO Palawan now invites bids for the above Procurement Project. Completion of the Works is required One Hundred Twenty (120) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from Philippine Ports Authority PMO Palawan Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M., Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on **June 2 - 21**, **2022** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
- 6. The Philippine Ports Authority PMO Palawan Bids and Awards Committee will hold a Pre-Bid Conference on June 09, 2022, 2:00 P.M. at Conference Room, 2nd Floor, PPA Administrative Building, Port Area, Puerto Princesa City and/or through videoconferencing/webcasting *via Zoom*, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **9:00 A.M.** of **June 21, 2022.** Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on **June 21, 2022, 9:30 A.M.** at Conference Room, 2nd Floor, PPA PMO–Palawan Administrative Building, Port Area, Puerto Princesa City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Philippine Ports Authority** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
