The Philippine Ports Authority - PMO Palawan Disposal Committee for Unserviceable Properties invites all interested parties to bid for the sale on an "AS IS - WHERE IS" basis, of TWO (2) LOTS UNSERVICEABLE PROPERTIES at PMO Palawan Baseport, Puerto Princesa City; the LISTS of which are hereto attached as "Annex A" and "Annex B".

The minimum acceptable bid price for the Lot under IIR No. 10-17-PLW is <u>Eleven Thousand Two Hundred Pesos</u> (P11,200.00), Vat included; and for the Lot under IIR No. 12-17-PLW is <u>Eleven Thousand Two Hunded Pesos</u> (P11,200.00), Vat included.

The items may be inspected by interested parties at the PPA, PMO Palawan Baseport, Port Area, Puerto Princesa City on working days from 8:00 A.M. to 5:00 P.M. upon prior notice to the Administrative Division, Second Floor of PPA Administrative Bldg., Port Area, Puerto Princesa City.

Bid forms can be secured on working days starting September 12, 2017 and until September 22, 2017 from the PMO Disposal Committee Secretariat upon payment of a non-refundable fee of P 50.00.

A Bidder shall accomplish the Bid Tender or Bid Form in at least three (3) copies, preferably in print or typewritten. Bid Tenders should be properly signed and submitted to the Chairperson of the Disposal Committee on or before the time scheduled for the opening of the bids. The envelope containing the bid tender should be sealed and addressed properly and correctly. Erasures or interlineations should be avoided or duly initialed by the bidder.

<u>Submission and opening</u> of duly accomplished bid forms in sealed envelope shall not be later\_than <u>9:30 A.M.</u> and 10:00 A.M., respectively, on <u>September 22, 2017</u> at the PPA Conference Room, 2<sup>nd</sup> Floor of PPA Admin. Bldg., Port Area, Puerto Princesa City.

**Bid Bond** in the form of Cash, Manager's Check or Cashier's Check <u>equivalent to 10% of the bid price</u> shall be submitted together with the BID.

Philippine Ports Authority reserves the right to reject any or all bids, to waive any required formality in the bids received or to accept any offer that it considers most advantageous to the Authority.
