

INVITATION FOR NEGOTIATED PROCUREMENT

- In view of Resolution No. 01 series of 2019 entitled "A Resolution Recommending Negotiation Procurement of the project: DOTC-LFP-PLW-02-2015 – BUSUANGA PORT DEVELOPMENT PROJECT, PORT OF BUSUANGA, BUSUANGA, PALAWAN" dated January 30, 2019, the PMO-Palawan BAC (Bids and Awards Committee for the Goods, for Consultancy Services and for the Engineering Projects) of the Philippine Ports Authority-PMO Palawan invites interested PhilGEPs registered contractors to participate in the negotiation for the project, re: DOTC-LFP-PLW-02-2015 BUSUANGA PORT DEVELOPMENT PROJECT, PORT OF BUSUANGA, BUSUANGA, PALAWAN with an Approved Budget for the Contract (ABC) of Nineteen Million Four Hundred Fifty Five Thousand Six Hundred Three & 38/100 Pesos (P 19,455,603.38) in accordance with Section 53.1 of R.A. 9184 and its 2016 Revised Implementing Rules and Regulations, otherwise known as the "Government Procurement Reform Act".

- 3. The negotiated procurement is restricted to Filipino citizen/sole proprietorship, organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Bidders shall submit one (1) original and four (4) duplicate copies of the following documents in properly **Book Bound**, **SEALED** and **MARKED** envelopes.
 - a. Certificate of PhilGEPS Registration (Platinum Membership)
 - b. PCAB License and Registration: at least <u>Small B Ports, Harbor &</u> Offshore Engineering
 - c. Statement of all ongoing government and private contracts
 - d. Statement of Single Largest Completed Contracts similar to the project
 - e. NFCC Computation
 - f. Project Requirements
 - g. Omnibus Sworn Statement
 - h. Other Documents required under BID Documents
- Deadline for the submission of the eligibility documents, technical documents and financial documents will be on September 27, 2019, 8:30 A.M. Opening of proposal will immediately follow at the Conference Room, 2nd Floor, Admin. Building, Port Area, Puerto Princesa City.
