INVITATION TO BID

FOR THE MAINTENANCE OF VARIOUS PORT PHYSICAL FACILITIES, PORT OF BROOKE'S POINT, BROOKE'S POINT, PALAWAN

The Philippine Ports Authority PMO-Palawan, through the Corporate Budget of the Authority for CY 2017, intends to apply the sum **₱ 3,402,718.40** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Maintenance of Various Port Physical Facilities, Port of Brooke's Point, Brooke's Point, Palawan (MPF-PLW-06-2017)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority – PMO Palawan now invites bids **A. Dismantling/Demolition/Excavation Works B. Concrete Works C. Masonry Works D. Welding Works E. Carpentry Works F. Roofing Works G. Electrical Works H. Painting Works I. Landscaping Work J. Clearing and Disposal Works**. Completion of the Works is required in **120 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary **“pass/fail”** criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Philippine Ports Authority PMO-Palawan Bids and Awards Committee (BAC) for Engineering Projects and inspect the Bidding Documents at the address given below from **8:00 a. m. to 5:00 p.m.**, Monday to Friday.

A complete set of Bidding Documents may be acquired by interested Bidders on **17 October 2017** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS (₱ 5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at the website of the Philippine Ports Authority, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids must be duly received by the BAC Secretariat at the address below on or before **8:30 a.m. of 07 November 2017**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the bidding documents.

Bid opening shall be on **07 November 2017, 9:00 a.m.** at Social Hall, 3rd Floor, PPA PMO-Palawan Administrative Building, Port Area, Puerto Princesa City. Bids will be opened in the presence of the bidder's representatives who choose to attend. Late bids shall not be accepted.
