# Invitation to Bid for Repair and Maintenance of Port Facilities at PMOPanay/Guimaras, CY 2018 

1. The Philippine Ports Authority, PMO-Panay/Guimaras, through the PPA Corporate Fund ( $R / M$ 2018) intends to apply the sum of Four Million Two Hundred Forty-Nine Thousand, Seven Hundred Ninety-Seven Pesos and 00/100 (P 4,249,797.00) being the Approved Budget for the Contract ( ABC ) to payments under the contract for "Repair and Maintenance of Port Facilities at PMO-Panay/Guimaras, CY 2018 (A1800100)" Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Ports Authority, PMO-Panay/Guimaras now invites bids for

- Improvement of PPA Office at Iloilo Fast Craft Terminal
- Supply, Fabricate and Install Canopy and Guard Rails at Iloilo Fast Craft Terminal
- Improvement of Public Assistance Desk at IFT
- Installation of Buffer Fence at the Quay Side of IFT
- Maintenance of Perimeter Fence and Gates along IRW, Muelle Loney Side
- Clearing and Improvement of Unpaved Apron at Iloilo River Wharf, Muelle Loney Side
- Demolition of Existing Streetlights along Lapuz, RoRo Berth

Completion of the Works is required 225 Calendar Days from the effective date of the contract. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent ( $75 \%$ ) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Engineering Services Division, Philippine Ports Authority, PMO-Panay/Guimaras and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm.
5. A complete set of Bidding Documents may be acquired by interested bidders starting May 11, 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5, 000.00) VAT Exclusive.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The Philippine Ports Authority, PMO-Panay/Guimaras will hold a Pre-Bid Conference ${ }^{1}$ on May 18, 2018, 10:00 A.M at the PPA Conference Room, $2^{\text {nd }}$ Floor, Admin. Bldg., ICPC, Iloilo City which shall be open to prospective bidders.

Bid opening shall be on May 31, 2018 at 9:00 in the morning at the PPA Conference Room, $2^{\text {nd }}$ Floor, Admin. Bldg., ICPC, Iloilo City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
