



Invitation to Bid for

“Repair/Replacement of Damaged Fendering System at Lapuz-Side of Iloilo River Wharf, Port of Iloilo, Iloilo City”

1. The *Philippine Ports Authority, PMO-Panay/Guimaras*, through the *PPA Corporate Fund (R/M 2018)* intends to apply the sum of ***Twenty-Nine Million, Two Hundred Ten Thousand, Nine Hundred Forty-Five Pesos and 2/100 (P29,210,945.02)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***“Repair/Replacement of Damaged Fendering System at Lapuz-Side of Iloilo River Wharf, Port of Iloilo, Iloilo City (A180038)”*** Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Philippine Ports Authority, PMO-Panay/Guimaras* now invites bids for

 - 6.0 *Supply and Deliver 400Hx1000L HV-Type RDF w/ Complete Accessories*
 - 7.0 *Install 400Hx1000L HV-Type RDF w/ Complete Accessories*
 - 8.0 *Performance Test of RDF Samples*
2. Completion of the Works is required *150 Calendar Days from the effective date of the contract*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.**
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *Engineering Services Division, Philippine Ports Authority, PMO-Panay/Guimaras* and inspect the Bidding Documents at the address given below from **8:00am to 5:00pm**.
5. A complete set of Bidding Documents may be acquired by interested bidders starting **July 9, 2018** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (P25, 000.00) VAT Exclusive*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Philippine Ports Authority, PMO-Panay/Guimaras* will hold a Pre-Bid Conference on **July 17, 2018, 10:00 A.M** at the **Engineering Services Division, 3rd Floor, Admin. Bldg., ICPC, Iloilo City** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **July 30, 2018 at 8:30 in the morning** at the **Engineering Services Division, 3rd Floor, Admin. Bldg., ICPC, Iloilo City**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **July 30, 2018 at 9:00 in the morning** at the **Engineering Services Division, 3rd Floor, Admin. Bldg., ICPC, Iloilo City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
