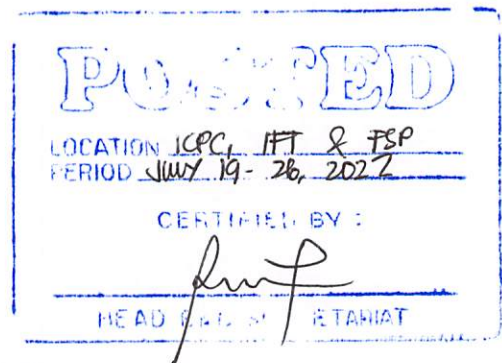



**Invitation to Bid for**  
**“REPAIR AND MAINTENANCE OF PHYSICAL FACILITIES AT**  
**PMO PANAY/GUIMARAS CY 2022”**

1. The *Philippine Ports Authority, PMO-Panay/Guimaras*, through the PPA Corporate Fund (R/M 2022) intends to apply the sum of ***Two Million Three Hundred Thirty-Four Thousand Four Hundred Seventy-Seven Pesos and 89/100(P 2,334,477.89)*** being the Approved Budget for the Contract (ABC) to payments under the contract for “***Repair and Maintenance of Physical Facilities at PMO Panay/Guimaras CY 2022***” (*Repair and Infrastructure Assets – A220011*). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine Ports Authority, PMO-Panay/Guimaras* now invites bids for the above Procurement Project. Completion of the Works is required ***150 Calendar Days***. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Philippine Ports Authority, PMO-Panay/Guimaras* and inspect the Bidding Documents at the address given below from 8:30am to 5:00pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on *July 20, 2022* from given address *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ph 5,000.00 exclusive of VAT*). The Procuring Entity shall allow the bidder to present its proof of payment for the fees [*presented in person, by facsimile, or through electronic means.*]
6. The *Philippine Ports Authority, PMO-Panay/Guimaras* will hold a Pre-Bid Conference<sup>1</sup> on *July 27, 2022, 10:00 A.M (PPA Time)* at the *PPA Conference Room, 2nd Floor, Admin. Bldg., ICPC, Iloilo City* and/or may attend virtually through videoconferencing/webcasting *via Zoom application*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below,
