**INVITATION TO BID FOR**


**“GARBAGE COLLECTION AND DISPOSAL AT BASEPORT FOR CY 2020”**

1. The Philippine Ports Authority (PPA), Port Management Office-Panay/Guimaras, through the CY2019 Corporate Funds intends to apply the sum of in PESOS: **ONE MILLION FOUR HUNDRED NINETY THOUSAND NINE HUNDRED TWENTY-TWO PESOS & 56/100 (Php 1,490,922.56)** being the Approved Budget for the Contract (ABC) to payments under the contract for **“GARBAGE COLLECTION AND DISPOSAL AT BASEPORT FOR CY 2020”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Ports Authority (PPA), Port Management Office-Panay/Guimaras now invites bids for **“GARBAGE COLLECTION AND DISPOSAL AT BASEPORT FOR CY 2020”**. Delivery of the Goods/Services is required within **Two Hundred Twelve Calendar (212) Days** duration upon receipt of Notice to Proceed. Bidders should have completed, within Five (5) Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the Philippine Ports Authority (PPA), Port Management Office-Panay/Guimaras and inspect the Bidding Documents at the address given below during office hours from **8:30 a.m. to 4:30 p.m.**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **July 27, 2020** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (Php5,000.00) exclusive of VAT**.  
  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The *Philippine Ports Authority (PPA)*, *Port Management Office-Panay/Guimaras* will hold a Pre-Bid Conference on **July 31, 2020, 10:00 A.M (PPA time)** at the **PPA Conference Room, 2nd floor, Administration Building, Iloilo Commercial Port Complex (ICPC), Brgy. Loboc, La Paz**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **August 12, 2020, 8:30 A.M. (PPA time)**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on *August 12, 2020, 9:00 A.M (PPA time)* at *PPA Conference Room, 2nd floor, Administration Building, Iloilo Commercial Port Complex (ICPC), Brgy. Loboc, La Paz*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The bidder shall drop one (1) sealed envelope in the bid box as specified in the Instruction to Bidder Clause 20 and Bid Data Sheet for Sealing and Markings of the envelopes
9. The *Philippine Ports Authority (PPA), Port Management Office-Panay/Guimaras* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
