**INVITATION FOR SUBMISSION OF QUOTATION**  
(Small Value Procurement)

The Philippine Ports Authority, Port Management Office of Negros Oriental/Siquijor, through its Bids and Awards Committee-Procurement of Good and Services, invites qualified consultants to submit price quotation for the Procurement of Consultancy Services for the Processing and Securing of Permit to Operate for the Three (3) Units Power Generator Sets at the Ports of Dumaguete and Siquijor.

The consultancy service contract shall be according to the attached Terms of Reference and shall be for the processing and securing of Permit to Operate including other activities required therein. The consultancy contract shall cover the three (3) generator sets at the Port of Dumaguete (80kVA and 150kVA) and the Port of Siquijor (150kVA) in compliance with the regulation of Clean Air Act of 1999, and DENR Administrative Order (DAO) No. 192.

Contract duration is two (2) months with an Approved Budget for the Contract amounting to Sixty Eight Thousand Pesos (P 68,000.00).

Procurement will be conducted in consonance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of RA 9184. Only sealed bids/canvass from eligible consultants will be opened and a Purchase Order will only be awarded to the Lowest Calculated Responsive Bidder determined as such during post-qualification.

Request for Price Quotation must be submitted in a sealed envelope together with the following documents:

- a) DTI or SEC Registration;
- b) Valid and Current Mayor's Permit;
- c) PhilGEPS Registration;
- d) Tax Identification Number; and
- e) PCO Certificate of Accreditation from DENR.
