

REPOSTING OF INVITATION TO BID

FOR

Repair of Damaged Port Facilities, Port of Tandayag, Amlan, Negros Oriental (NRP-NOS-01-18)

- The *Philippine Ports Authority, Port Management Office of Negros Oriental-Siquijor (PPA, PMO-NO/S)*, through the Corporate Budget of the Authority for CY 2018 intends to apply the sum of ₱ 13,136,216.73, being the Approved Budget for the Contract (ABC) to payments under the contract for Repair of Damaged Port Facilites, Port of Tandayag, Amlan, Negros Oriental (NRP-NOS-01-18). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PPA, PMO-NOS now invites bids for **Repair of Damaged Port Facilites**, **Port of Tandayag**, **Amlan**, **Negros Oriental (NRP-NOS-01-18)**.

Completion of the Works is required for **Three Hundred (300) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested bidders may obtain further information from *PPA*, *PMO-NO/S* and inspect the Bidding Documents at the address given below from 8:00 a.m. 5:00 p.m., Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested bidders starting September 26, 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱ 12,880.00 (VAT Inclusive).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. **PPA, PMO-NO/S** will hold a Pre-Bid Conference on **October 4, 2018 at 10:00 A.M.** at *Philippine Ports Authority, PMO-NOS Conference Room, Robinsons Townville, Perdices Street, Dumaguete City,* which shall be open to prospective bidders. Bids must be duly received by the BAC Secretariat at the address below on or before **October 18, 2018 at 9:30 a.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **October 18, 2018, 10:00 a.m.** at Philippine Ports Authority, PMO-NOS Conference Room, Robinsons Townville, Perdices Street, Dumaguete City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
