

## **Invitation to Bid**

## For The

## REPAIR OF SCOURED RECLAMATION AREA, DAMAGED CURTAIN WALL AT BERTH 6, DAMAGED PILE/PILE CAPS AT RAMP 4 AND DAMAGED RORO RAMP 3, PORT OF DUMAGUETE, DUMAGUETE CITY (NRP-NOS-04-21)

- 1. The Philippine Ports Authority, Port Management Office of Negros Oriental/Siquijor (PPA, PMO-NOS), through the Corporate Budget of the Authority for CY 2021 intends to apply the sum of ₱ 25,663,539.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Repair of Scoured Reclamation Area, Damaged Curtain Wall at Berth 6, Damaged Pile/Pile Caps at Ramp 4 and Damaged Roro Ramp 3, Port of Dumaguete, Dumaguete City (NRP-NOS-04-21). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *PPA*, *PMO-NOS* now invites bids for the above Procurement Project. Completion of the Works is required *Three Hundred (300) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *PPA*, *PMO-NOS* and inspect the Bidding Documents at the address given below from 8:00 am 5:00 pm, *Monday to Friday*.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *October 15, 2021* from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱ 25,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
- 6. The **PPA**, **PMO-NOS** will hold a Pre-Bid Conference on October 27, 2021; 02:00 PM at Philippine Ports Authority, PMO-NOS Conference Room, Port Operation Building, Port Area, Looc, Dumaguete City and/or through videoconferencing/webcasting via Microsoft Teams, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *November 12, 2021, 09:30 AM*. Late bids shall not be accepted.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *November 12, 2021; 10:00 AM* at the given address below and/or through *Microsoft Teams*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *PPA*, *PMO-NOS* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
