



## INVITATION TO BID

FOR

***Supply, Delivery and Installation of Various Furniture, Fixtures and Equipment for the Port Operations Building (POB) of PMO-Negros Oriental/Siquijor (PMO-NOS) and its Terminal Management Offices (TMOs), Port Manager's Quarter (PMQ) and Guest Quarters (GQs)***

1. The *Philippine Ports Authority, Port Management Office of Negros Oriental/Siquijor (PPA, PMO-NOS)*, through the *Corporate Budget for the Contract approved by the governing Boards for CY 2019* intends to apply the sum of ₱ 4,364,700.00 being the Approved Budget for the Contract (ABC) to payments under the contract for *Supply, Delivery and Installation of Various Furniture, Fixtures and Equipment for the Port Operations Building (POB) of PMO-Negros Oriental/Siquijor (PMO-NOS) and its Terminal Management Offices, Port Manager's Quarter (PMQ) and Guest Quarters (GQs)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine Ports Authority, Port Management Office of Negros Oriental/Siquijor (PPA, PMO-NOS)* now invites bids for *Supply, Delivery and Installation of Various Furniture, Fixtures and Equipment for the Port Operations Building (POB) of PMO-Negros Oriental/Siquijor (PMO-NOS) and its Terminal Management Offices, Port Manager's Quarter (PMQ) and Guest Quarters (GQs)*. Delivery of the Goods is required for *One Hundred Twenty (120) Calendar Days*. Bidders should have completed, within *One Hundred Twenty (120) Calendar Days* from the date of receipt of Notice to Proceed. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from *Philippine Ports Authority, Port Management Office of Negros Oriental/Siquijor (PPA, PMO-NOS)* and inspect the Bidding Documents at the address given below during 8:00 a.m. – 5:00 p.m., *Monday to Friday*.

5. A complete set of Bidding Documents may be acquired by interested Bidders on *November 12, 2019* from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱ 5,000.00.*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Philippine Ports Authority, Port Management Office of Negros Oriental/Siquijor (PPA, PMO-NOS)* will hold a Pre-Bid Conference on *November 21, 2019 at 10:00 am* at *Philippine Ports Authority, PMO-NOS Conference Room, Robinsons Townville, Perdices Street, Dumaguete City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *December 4, 2019 at 09:30 am*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
8. Bid opening shall be on *December 4, 2019 at 2:00 pm* at *Philippine Ports Authority, PMO-NOS Conference Room, Robinsons Townville, Perdices Street, Dumaguete City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The *Philippine Ports Authority, Port Management Office of Negros Oriental/Siquijor (PPA, PMO-NOS)* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
