
***INVITATION TO BID  
FOR THE  
PROCUREMENT OF ONE (1) LOT  
INFORMATION AND COMMUNICATION  
TECHNOLOGY (ICT) EQUIPMENT  
FOR THE DIVISIONS OF PMO-NEGROS  
OCCIDENTAL/BACOLOD/BB***

1. The Philippine Ports Authority's Port Management Office of Negros Occidental/Bacolod/BB (PPA PMO-NBB), through the Approved *Corporate Operating Budget for 2021 Ref. No. 202100155*, intends to apply the sum of *One Million, Four Hundred Thirty-Five Thousand Pesos (P1,435,000.00)* being the ABC to payments under the contract for the *Procurement of One (1) Lot Information and Communication Technology Equipment*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PPA PMO-NBB now invites bids for the above Procurement Project. Delivery of the Goods is required within a period of forty-five (45) calendar days from receipt of notice to proceed. Bidders should have completed, within a period of three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from PPA PMO-NBB and inspect the Bidding Documents at the address given below during office hours from 8:00 A.M. to 5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on June 25, 2021 from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand, Six Hundred Pesos (P5,600.00) inclusive of VAT*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The PPA PMO-NBB will hold a Pre-Bid Conference on *July 2, 2021 9:30 A.M. at the PPA PMO-NBB Bldg., Banago Port, Banago, Bacolod City, and/or through video conferencing or webcasting via either Zoom Video or MS Teams* which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *July 14, 2021 9:00 A.M.* Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on *July 14, 2021 at 10:00 A.M.* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *PPA PMO-NBB* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
