This public bidding/auction shall be conducted pursuant to DBM National Budget Circular No. 425 dated 28 January 1992, in so far as it conforms and harmonizes with pertinent COA issuances.

Interested bidders/auctioneers shall submit a Letter of Intent (LOI) addressed to Chairperson of the Disposal Committee along with pertinent legal requirements thru the Secretariat, such as but not limited to the following:

1. Current Business Permit;
2. Registration certificate from SEC, Department of Trade and Industry (DTI) for sole proprietorship, or CDA for cooperatives; and
3. Certificate of Site Inspection duly signed by the Administrative Division Manager

The Bid Proposals shall include copies of the Letter of Intent and other documents mentioned in the preceding paragraph which have been duly received by the Secretariat before deadline of June 5, 2018. These shall be enclosed in three (3) separately sealed envelopes and must be submitted not later than 9:30 AM of June 14, 2018. **Late Bid Proposals shall not be accepted.**

Prospective bidders are invited to attend the Pre-Auction Conference on the time, date and place indicated above. Only bid tender which confirm compliance with the requirements set forth in this public bidding/auction as determined by the Property Disposal Committee during the opening/evaluation of bids, shall be eligible for the opening of its bid proposal or buying priced by using the form prescribed.


The bond shall be submitted together with the proposal or buying price, in accordance with the following conditions: 1) At least 10% of the proposed bid/buying price, and 2) should be in the form of cash, manager's check or cashier's check acquired from a reputable bank within the area where the bidding auction is to be held.

Bidder/Auctioneers or its authorized representative(s) may inspect the above-mentioned properties before submitting their sealed bids to the Property Disposal Committee at the above stated place, date and time.

The Philippine Ports Authority reserves the right to accept or reject any Bid, to annul the auctions/bidding process, and to reject bid proposal at any time prior to award, without thereby incurring any liability to the affected Bidders/Auctioneers.
