## INVITATION TO BID

**Project Title & Code:** Maintenance of Existing Powerhouse, Port of Cagayan de Oro (MPF-MOC-61-2025)  
**Project Location:** Port of Cagayan de Oro

The **Philippine Ports Authority - PMO Misamis Oriental/Cagayan de Oro (PPA PMO MOC)**, through the PPA Corporate Budget for CY 2025, intends to apply the sum of **Four Hundred Twenty-One Thousand One Hundred Seventy-Eight and 29/100 only (₱421,178.29)** being the **Approved Budget for Contract (ABC)** to payments under the contract above. Bids received more than the ABC shall be automatically rejected at Bid opening.

1. The PPA PMO MOC invites potential Bidders with Platinum membership in PhilGEPS to apply for eligibility and to bid for the abovementioned project.
2. Applications for eligibility will be evaluated on a "pass/fail" basis. Submission of the accomplished Eligibility Documents and bids/canvass to the BAC Secretariat is on **October 14, 2025, 8:30 A.M. at the Engineering Services Division Office, Amenity Bldg. 3, Bldg. 2 Grounds, Port Area, Gate 4, Brgy. Puntod, Cagayan de Oro City**. Opening of Bids/Canvass shall be on **October 14, 2025, at 10:00 AM at the GAD Hall of the same building**.
3. A detailed canvass form may be purchased by interested Bidders and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Five Hundred Pesos only (₱ 500.00)**.
4. Procurement will be conducted in consonance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act 9184, per GPPB resolution No. 03-2009, otherwise known as the "Government Procurement Reform Act". Only sealed bids/canvass from eligible bidders will be opened and a contract will only be awarded to the Single/Lowest Calculated and Responsive Bidder who was determined as such during post-qualification.
5. The PPA PMO MOC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
