



Invitation to Bid for the Rehabilitation of Amenity Building Port of Cagayan de Oro

1. The *Philippine Ports Authority (PPA)*, *Port Management Office of Misamis Oriental / Cagayan de Oro (PMO/MOC)*, through the *Corporate Budget for the year 2020* intends to apply the sum of **Sixty Five Million Three Hundred Thirty Six Thousand Six Hundred Thirty Three Pesos & 66/100 (P65,336,633.66)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Rehabilitation of Amenity Building, Port of Cagayan de Oro** with Project ID # C200003. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Ports Authority Port Management Office of Misamis Oriental / Cagayan de Oro (PMO/MOC), now invites bids for the above Procurement Project. Completion of the Works is 210 Calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from Philippine Ports Authority, PMO of Misamis Oriental/Cagayan de Oro Bids & Awards Committee (BAC) and inspect the Bidding Documents at the address given below from **8:00AM to 5:00 PM**.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees by submitting second copy of official receipt to the BAC Secretariat in the address given below.

The Philippine Ports Authority, PMO Misamis Oriental / Cagayan de Oro Bids and Awards Committee will hold a Pre-Bid Conference on **20 November 2020 at 9:00A.M.** at the GAD Hall of PMO Misamis Oriental / Cagayan de Oro, 3/F PMO Building #2, Port Area, Macabalan, Cagayan de Oro City and/or through video

conferencing / webcasting via Google Meet (link will be provided upon purchasing the Bid Documents), which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat on or before **8:00 A.M. of 02 December 2020** through manual submission at the office address as indicated below. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **02 December 2020 at 9:00AM** at the GAD Hall of PMO Misamis Oriental / Cagayan de Oro, 3/F PMO Building #2 and/or through Google Meet (link will be provided upon purchasing the Bid Documents). Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Prospective bidders must possess a valid PCAB license and registration of at least Medium "A" (License Category B) for Port, Harbor and Offshore Engineering and Medium "A" (License Category B) for Building and Industrial.
11. The Philippine Ports Authority, Port Management Office of Misamis Oriental / Cagayan de Oro (PMO/MOC) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
