The **Philippine Ports Authority – Port Management Office of SOCSARGEN**, through the **Corporate Budget for the contract approved by the governing Boards for CY 2023** intends to apply the sum of **Nine Hundred Twelve Thousand Seven Hundred Seventy-Nine Pesos and 95/100 Only (P 912,779.95) Inclusive of 5% VAT** being the Approved Budget for the Contract (ABC) to payments under the contract for **ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 1: (1) REPAINTING OF GI CHAINS, SHACKLES AND ACCESSORIES AT RORO AND NEWLY CONSTRUCTED WHARF AND REPAINTING OF BOLLARDS ALONG CAL.000-851; (2) REPAIR OF SETTLED PAVING BLOCKS AT CY1 & CY3; (3) REPAIR OF CHB PERIMETER FENCE AT HOLCIM AREA, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY: RMP-SSG-01-2023**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Ports Authority – Port Management Office of SOCSARGEN** now invites bids for the above Procurement Project. Completion of the Works is required **One Hundred (100) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Secretariat of the BAC, Philippine Ports Authority – Port Management Office of SOCSARGEN** and inspect the Bidding Documents at the address given below from **8:00 a.m. to 5:00 P.M., Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **May 5, 2023 up to the deadline for the submission and receipt of bids** from **given address and website/s below** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos (P 1,000.00) plus 12% VAT**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person or through the email address provided in this Invitation to bid**.
6. The **Philippine Ports Authority – Port Management Office of SOCSARGEN** will hold a Pre-Bid Conference¹ on **May 12, 2023, 9:00 A.M.** at **PPA- PMO SOCSARGEN, Port Operations Building - Conference Room #2, Makar Wharf,**



Labangal, General Santos City or through videoconferencing/webcasting via zoom application which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through **any of the following: (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both** on or before **9:00 A.M., May 25, 2023**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
9. Bid opening shall be on **May 25, 2023, at 9:30 A.M.** **PPA- PMO SOCSARGEN, Port Operations Building - Conference Room #2, Makar Wharf, Labangal, General Santos City and/or through zoom application**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Upon purchase of bidding documents, **Philippine Ports Authority – Port Management Office of SOCSARGEN** will provide the secured link where the bidder can upload files representing online bid submission. **The link shall automatically expire after 9:00 am of May 25, 2023 and the bidder can no longer upload additional documents.**
11. Required PCAB Registration or Special PCAB License in case of Joint Ventures : **Small A**
12. The **Philippine Ports Authority – Port Management Office of SOCSARGEN** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.1 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
