



## Invitation to Bid

The **Philippine Ports Authority – Port Management Office of SOCSARGEN**, through the **Corporate Budget for the contract approved by the governing Boards for CY 2019** intends to apply the sum of PESOS: **Eighteen Million Four Hundred Twelve Thousand Six Hundred Seventeen Pesos and 14/100 Only (P 18,412,617.14) Inclusive of 12% VAT** being the Approved Budget for the Contract (ABC) to payments under the contract for the **INSTALLATION OF NEW CYLINDRICAL RUBBER DOCK FENDER AND ACCESSORIES AT CAL. 000-030 AND CAL. 255-290; AND INSTALLATION OF 18 UNITS NEW 50T MOORING BOLLARD, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Completion of the Works is required to be completed within **One Hundred Twenty (120) Calendar Days**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

1. Bidding will be conducted through open competitive bidding procedures using **non-discretionary “pass/fail” criterion** as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

2. Interested bidders may obtain further information from the **Secretariat of the BAC, Philippine Ports Authority – Port Management Office of SOCSARGEN** and inspect and procure the Bidding Documents at the address given below from **8:00 a.m. to 5:00 P.M., Monday to Friday**.
3. A complete set of Bidding Documents may be acquired by interested bidders on **August 28, 2019 up to the deadline for the submission and receipt of bids** from the

address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty Five Thousand Pesos (P 25,000.00) plus 12% VAT.**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

4. The **Philippine Ports Authority – Port Management Office of SOCSARGEN Bids and Awards Committee** will hold a **Pre-Bid Conference** on **September 3, 2019, 2:00 P.M.** at **PPA- PMO SOCSARGEN, Port Operations Building - Conference Room #2, Makar Wharf, Labangal, General Santos City**, which shall be open to prospective bidders.
5. Bids must be duly received by the BAC Secretariat at the address below on or before **9:00 A.M., September 23, 2019** at the **PPA Port Management Office of SOCSARGEN, Port Operations Building, Lobby Area, Labangal, General Santos City**. All bids must be accompanied by a Bid Securing Declaration **OR** a Bid Security , in an amount not less than the required percentage of the ABC in accordance with following schedule:

Bid Opening shall be on **September 23, 2019** at **at 1:30 P.M.** **PPA- PMO SOCSARGEN, Port Operations Building - Conference Room #2, Makar Wharf, Labangal, General Santos City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

6. The requirement that the Bidder must have completed, within ten (10) years from the submission of bids, a single contract that is similar to this project, the ABC of which should be equivalent to at least fifty percent (50%) of the ABC of this project, **is no longer necessary**.
