

**RE-INVITATION TO BID
FOR
PROCUREMENT OF NEW BRANDED DESKTOP
COMPUTER SETS**

1. The **Philippine Ports Authority – Port Management Office of SOCSARGEN**, through the **Corporate Budget for the contract approved by the governing Boards for CY 2021** intends to apply the sum of **One Million Seven Hundred Fifty Thousand Only (P 1,750,000.00) Inclusive of 12% VAT** being the ABC to payments under the contract for **PROCUREMENT OF NEW BRANDED DESKTOP COMPUTER SETS**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Ports Authority – Port Management Office of SOCSARGEN** now invites bids for the above Procurement Project. Delivery of the Goods is required **within forty-five (45) calendar days from the receipt of the successful bidder of the Notice to Proceed. However, at least 50% of the total quantity must be delivered within thirty (30) calendar days from the date of receipt of NTP**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Prospective Bidders may obtain further information from **Secretariat of the BAC, Philippine Ports Authority – Port Management Office of SOCSARGEN** and inspect the Bidding Documents at the address given below from **8:00 a.m. to 5:00 P.M., Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **September 28, 2021 up to the deadline for the submission and receipt of bids** from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P 5,000.00) plus 12% VAT**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person or through electronic means**.
6. The **Philippine Ports Authority – Port Management Office of SOCSARGEN Bids and Awards Committee** will hold a **Pre-Bid Conference on October 5, 2021 9:00 AM** at **PPA- PMO SOCSARGEN, Port Operations Building - Conference Room #1, Makar Wharf, Labangal, General Santos City** and/or through video conferencing or *via Zoom* which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat **through manual submission at the Office address indicated below** on or before **October 18, 2021 9:00AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. **Bid Opening** shall be on **October 18, 2021 9:30AM** at the **PPA Port Management Office of SOCSARGEN, Port Operations Building, Conference Room #1, Labangal, General Santos City** and/or **video conferencing or via Zoom**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
