

INVITATION TO BID FOR THE

One (1) Lot Provision of various supplies and materials for the 853 KVA Generator Set for PPA, PMO-Zamboanga, Zamboanga City

1. The Philippine Ports Authority (PPA), Port Management Office (PMO)-Zamboanga, through the Corporate funds for CY 2019, intends to apply the total sum of **Four Million Six Hundred Sixty Seven Thousand Five Hundred Sixty Five Pesos & 50/100 (Php4,667,565.50)**, inclusive of 12% VAT being the Approved Budget for the Contract (ABC) for the Public Bidding of the project: One (1) Lot Provision of various supplies and materials for the 853 KVA Generator Set for PPA, PMO-Zamboanga, Zamboanga City. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PPA, PMO-Zamboanga Bids and Awards Committee now invites bids for the said project consisting of various supplies and materials as follows:

3. The expected contract duration is Thirty (30) Calendar Days. Bidders should have completed within the last five (5) years, a contract similar to the Project to be bid whose value must be at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country

belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Division Office at Telephone Number (062) 991-2037/2038 local 111 and secure the Bidding Documents at the Admin. Division Office, 2nd Floor, PPA, Admin. Bldg., Port Area, Zamboanga City during office hours from 8:00AM-5:00PM, Monday to Friday except holidays.
6. A complete set of Bidding Documents may be purchased by interested Bidders starting December 16, 2019, upon payment of the applicable fee in the amount of Five Thousand Six Hundred Pesos (Php5,600.00), inclusive of 12% VAT. Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) at <http://www.philgeps.net> and the PPA website at <http://www.ppa.com.ph> provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The PPA, PMO-Zamboanga Bids and Awards Committee will hold a Pre-Bid Conference on December 23, 2019, at 10:00 AM, Conference Room, 2nd Floor, PPA Admin. Bldg., Port Area, Zamboanga City which shall be open to interested bidders.
8. Submission of Bids shall not be later than 2:00 PM, January 6, 2020 at the Admin. Division Office, 2nd Floor, PPA Admin. Bldg., Port Area, Zamboanga City. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **Instruction to Bidders**.

Opening of Bids shall be on January 6, 2020, at 2:00 PM, Conference Room, 2nd Floor, PPA Admin. Bldg., Port Area, Zamboanga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the said opening of bids. Late bids shall not be accepted.

9. The PPA, PMO-Zamboanga reserves the right to reject any or all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
