Qualifications:

An applicant shall submit proofs/documents that he possesses the following qualifications:

- A Filipino citizen;
- Not more than fifty-five (55) years old at the time the vacancy is announced for filling;
- Of sound physical and mental condition and of good moral character;
- Holder of a Maritime Industry Authority (MARINA) or Philippine Coast Guard (PCG) license as Harbor Pilot for the particular pilotage district applied for. Where no examination has yet been conducted by MARINA or PCG in that particular pilotage district, the applicant must at least be a holder of a harbor license in any pilotage district.

Documentary Requirements: (in three (3) copies)

- Application Letter together with a duly Sworn Information Sheet/Biodata;
- Certificate as Master Mariner;
- Copy of the Pilot's Examination Rating and License/Certificate issued by MARINA (or PCG) to practice as harbor pilot in the pilotage district applied for;
- Employer's Certification of Services Rendered as Shipmaster (name of vessels, tonnage, ports of call and length/period of service thereon, including frequency of calls on the pilotage waters applied for)
- Copies of Certificates of Training Courses attended, Positions/Qualifications and Commendations/Awards in the maritime/port service;
- Current Physical and Mental Fitness Certificates from a government physician, and current Board of Marine Inquiry (BMI) Clearance to the effect that no case has been filed, pending and/or decided against the applicant;
- If already a harbor pilot, a Certification from the Chief Pilot stating the length of service and pilotage districts/waters served, including vessels/tonnages handled as harbor pilot;
- Copy of Seafarer's Identification and Record Book (SIRB) for services rendered as Shipmaster;
- Other relevant information/documents that would support the application as harbor pilot.

Deadline for filing of application:	Not later than 5:00 PM of Oct. 27, 2022

Only those applications with complete documentary requirements received on or before the deadline set shall be processed. Incomplete applications shall not be considered.
