SUBJECT : Daily Status Report on the Implementation in the Seaports of the Presidential Directive for the Management of the 2019 Novel Corona Virus Acute Respiratory Disease Situation

Respectfully submitted is the status report on the implementation of PPA Memorandum Circular No. 01-2020, re the Implementation in the Seaports of the Presidential Directive for the Management of the 2019 Novel Corona Virus Acute Respiratory Disease Situation as of 1200H of February 14, 2020.

ACTIONS TAKEN

1. Informed the following Stakeholders and Shipping Agents during the operations meeting, on the DOH Circular No. 2020-0034 ' Guidelines at all Seaports for Prevention and Spread of Novel Coronavirus Acute Respiratory Disease (2019-NCOV ARD)
 - 1.1. Wave Industrial Sales
 - 1.2. Harbor Star Shipping Services Inc.
 - 1.3. Coralsea Port Services, Inc.
 - 1.4. Davao Integrated Port & Stevedoring Services Corp. (DIPSSCOR)

2. The Stakeholders were reminded to limit close contact to the vessel's crew especially of vessels which had previous port calls to China and it's SARs, to maintain a distance of at least 3-6 feet and to practice proper hygiene by washing their hands and sanitizing. Further encouraged to report workers with flu-like symptoms to their respective company nurses and to the PPA.
3. Advised the Shipping Agents to coordinate to the Port Police Division regarding embarking/disembarking of vessel crew and further inform that embarking/disembarking of the crew of vessels that called at any port in China and it's SAR is not allowed.

4. They were reminded of the additional requirements upon submission of NOA/ABA. The Shipping Line agents or representatives are required to provide a copy of their Voyage Memo, Free Pratique, Vessel's crew list/Maritime Declaration of Health and Quarantine Clearance of outgoing vessels or aircraft issued by the BOQ-DOH
5. Advised the said stakeholders to go to the DOH website (<https://www.doh.gov.ph/2019-nCoV/>) for updates and precautionary measures of 2019-nCoV.
6. Informed that Taiwan is included in the presidential directives stated in PPA MC 01-2020. The basis was the WHO one-China policy which is adapted by DOH and DFA to include Taiwan in the travel ban.
7. No records of any crew of a vessel that called in any port of China, Macau, Hong Kong, and Taiwan were allowed to disembark.


