**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
RENOVATION OF PPA HEAD OFFICE 6<sup>TH</sup> FLOOR LOBBY  
BAC-PGCS-110-2020**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Renovation of PPA Head Office 6<sup>th</sup> Floor Lobby, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 04 November 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 3,000,000.00**;

WHEREAS, in response to the said advertisement, only Cytracon Corporation secured the Bid Documents and submitted the Technical and Financial Proposals in the amount of **₱ 5,000.00**;

WHEREAS, during the opening of bids on 01 December 2020 at 10:00 a.m., Cytracon Corporation, the lone bidder, was declared "passed" in the requirements of the First Envelope.

WHEREAS, the Financial Proposal of Cytracon Corporation was opened and its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 03 December 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 04 December 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Cytracon Corporation;

WHEREAS Cytracon Corporation was declared as the Single Calculated Bidder in the amount of **₱ 2,994,525.94**;

WHEREAS, post-qualification was conducted on 10 December 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Cytracon Corporation, however, in the Post-Qualification Report on 18 December 2020, Cytracon Corporation was declared as "post-disqualified" for being non-responsive, pursuant to Rule X, Section 34 of the 2016 Revised IRR of RA 9184 considering that the quantities indicated in the Bill of Quantities are different from the required quantities in the Bill of Quantities issued by the BAC;

WHEREAS, Cytracon Corporation modified the duration for the provision of construction safety and health program for four (4) months instead of the required two (2) months per Bill of Quantities issued for the project;

WHEREAS, no request for reconsideration was filed by Cytracon Corporation within the prescribed deadline for submission thereof;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Renovation of PPA Head Office 6<sup>th</sup> Floor Lobby, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Opening of Bids for the Renovation of PPA Head Office 6<sup>th</sup> Floor, Repair and Maintenance of PPA Head Office Main Lobby and Repair and Maintenance of PPA Head Office Canteen held on 01 and 02 December 2020, which were declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution Nos.001-2021, 002-2021 and 003-2021 Series of 2021, recommending that the bidding for the above projects be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
