**DETAILED TECHNICAL AND FINANCIAL PROPOSALS EVALUATION
RESULTS AND IDENTIFICATION OF THE SINGLE RATED BID
FOR THE CONSULTANCY SERVICES FOR THE INVENTORY AND STRUCTURAL
INVESTIGATION SURVEY OF ALL MARINE STRUCTURES AND ITS
ACCESSORIES AT SELECTED PORTS NATIONWIDE
(PACKAGE 2)**

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Inventory and Structural Investigation Survey of all Marine Structures and its Accessories at Selected Ports Nationwide (Package 2), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 31 March 2023, continuously for seven (7) calendar days;

WHEREAS, in response thereto, two (2) consulting firms secured and submitted their Eligibility Documents, namely:

1. E. H. Sison Engineers, Co.
2. Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV

WHEREAS, after the Eligibility Screening conducted on 20 April 2023 at 10:00 a.m., E.H. Sison Engineers, Co. and Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV were declared eligible to bid for the project;

WHEREAS, in BAC Resolution No. CON 001-2023 dated 28 April 2023, Recommending Shortlist of Consultants for the Consultancy Services for the Inventory and Structural Investigation Survey of all Marine Structures and its Accessories at Selected Ports Nationwide (Package 2), E.H. Sison Engineers, Co. and Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV were declared as shortlisted consultants, as approved by the Head of the Procuring Entity (HOPE);

WHEREAS, only E.H. Sison Engineers, Co. dropped its Technical and Financial Proposals before the deadline prescribed for the submission of bid documents on 30 June 2023. Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV submitted its bid documents at 9:02 a.m. or after the prescribed deadline for submission thereof, hence the documents were stamped "LATE" and not accepted by the BAC Secretariat, pursuant to the 2016 Revised IRR of R.A. 9184 on late submission of bids;

WHEREAS, during the opening of the Technical Proposals (First Envelope) conducted on 30 June 2023 at 10:00 a.m., E.H. Sison Engineers, Co. was declared “passing” with the requirements of the First Envelope;

WHEREAS, after detailed evaluation of the Technical Proposals submitted by E.H. Sison Engineers, Co. on 14 June 2023, using the criteria specified in the Bidding Documents, the said evaluation resulted in the following:


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED as follows:


