**DECLARATION OF FAILURE OF BIDDING FOR THE PROJECT NCP-PLW-01-2018  
PROVISION OF MOVABLE COVERED WALK, PORT OF PUERTO PRINCESA,  
PALAWAN**

WHEREAS, the Philippine Ports Authority, PMO-Palawan advertised the Invitation to Bid for the project NCP-PLW-01-2018 Provision of Movable Covered Walk, Port of Puerto Princesa, Palawan at PhilGEPS and PPA websites and at the bulletin board of PMO-Palawan continuously from October 20, 2018 to November 12, 2018;

WHEREAS, in response to said advertisement, only one (1) prospective bidder/contractor secured and purchased bid documents namely, ORIENT STAR CONSTRUCTION, INC.;

WHEREAS, on 12 November 2018, the scheduled opening of bids, above-stated prospective bidder submitted their respective bid proposal;

WHEREAS, upon the examination of the bid documents of ORIENT STAR CONSTRUCTION, INC., the BAC found a discrepancy in the project ID number and project name indicated in the Financial Bid documents submitted by the bidder, is different from this Project's number/name as posted for bidding;

WHEREAS, the BAC unanimously agreed to declare the bid of ORIENT STAR CONSTRUCTION, INC. ineligible due to the above findings;

NOW THEREFORE, for and in consideration of the foregoing premises, the PMO-Palawan Bids and Awards Committee hereby resolves, as it hereby resolves, to declare the Bidding of NCP-PLW-01-2018 Provision of Movable Covered Walk, Port of Puerto Princesa, Palawan, a FAILURE;

RESOLVED FURTHER, to recommend to the Port Manager of PMO-Palawan, as the Head of Procuring Entity, to conduct a re-bidding with re-advertisement and/or posting of the subject project, as provided for in RA 9184 and its 2016 Revised IRR.
