Declaring as Failure the Bidding of the project MPF-PLW-02-18 Various Maintenance of Port Physical Facilities, Port of Coron, Coron, Palawan

WHEREAS, the Philippine Ports Authority, PMO-Palawan advertised the Invitation to Bid for the project MPF-PLW-02-18 Various Maintenance of Port Physical Facilities, Port of Coron, Coron, Palawan at PhilGEPS, PPA websites and at the bulletin board of PMO-Palawan continuously for twenty four (24) days from October 20 - November 12, 2018.

WHEREAS, in response to said advertisement, only one (1) prospective bidder/contractor secured and purchased bid documents namely,

1. ORIENT STAR CONSTRUCTION, INC.

WHEREAS, on November 12, 2018 at 2:00 P.M., the bid documents of ORIENT STAR CONSTRUCTION, INC. was opened, evaluated and was declared "PASSED" the preliminary examination of its Technical and Financial Bid requirements subject to detailed bid evaluation;

WHEREAS, on November 14 - 18, 2018, the Technical Working Group conducted the detailed evaluation on the bid submitted by ORIENT STAR CONSTRUCTION, INC. and had the following findings:


1. The bidder failed to submit the post- qualification documents in accordance with Section 34.2 of the Revised 2016 IRR of RA 9184 which states that,  
*"Failure to submit any of the post- qualification requirements on time, or a finding against the veracity thereof, shall disqualify the bidder for award."*

WHEREAS, during the Bid Evaluation Meeting on November 19, 2018 at 2:00 P.M., the BAC unanimously agreed to disqualify ORIENT STAR CONSTRUCTION, INC. due to the above findings;

NOW THEREFORE, for in consideration of the foregoing premises, the PMO-Palawan Bids and Award Committee hereby resolves, as it hereby resolves, to declare the Bidding of MPF-PLW-02-18 Various Maintenance of Port Physical Facilities, Port of Coron, Coron, Palawan, a FAILURE;

RESOLVED FURTHER, to recommend to the Port Manager of PMO-Palawan, as the Head of Procuring Entity, to conduct a re-bidding with re-advertisement and/or reposting of the subject project, as provided for in RA 9184 and its 2016 Revised IRR.




