
The meeting for the Opening of Bids was called to order by the Chairperson at 10:30 AM. The following transpired:

1. The BAC Secretariat read the attendees present in the PMO LNI Conference Room and those attending via Zoom platform. A quorum was declared and the floor was turned over to the TWG for the start of Opening of Bids.


2. The BAC Chairperson informed the attendees of the procedure to be followed in the procurement for the three projects shall be based on Section 53 – Negotiated Procurement, Subsection 53.9 – Small Value Procurement, of the amended Implementing Rules and Regulations of R.A. 9184.
3. The office invited three (3) bonafide bidders namely **R. DE MESA CONSTRUCTION, BRIMA CONSTRUCTION AND ENTERPRISES** and **J.C. DELA VEGA CONSTRUCTION** to submit price quotations for the above-mentioned projects to be supported with detailed cost estimates. **J.C. DELA VEGA CONSTRUCTION** did not submit their bid documents.
4. The TWG Member, Mr. Dennis Cambaya started with the Project **Repair of CHB Fence at Access Road, Port of Iligan, Iligan City** with the Approved Budget for the Contract of **₱995,500.00**. Bid document of **BRIMA CONSTRUCTION AND ENTERPRISES** and **R. DE MESA CONSTRUCTION** were opened. Each items were read aloud, screen shared and checked against the list of the required documents. Bid proposal documents of the bidders were found to have complied with the minimum requirements and offered the amount of **₱992,027.90** and **₱994,979.75** respectively to be completed in 50 calendar days.
5. For the Project **Installation of Steel Frame gate at 4th Street, Port of Iligan, Iligan City** with the Approved Budget for the Contract of **₱157,000.00**. Bid document of **BRIMA CONSTRUCTION AND ENTERPRISES** and **R. DE MESA CONSTRUCTION** were opened. Each items were read aloud, screen shared and checked against the list of the required documents. Bid proposal documents of the bidders were found to have complied with the minimum requirements and offered the amount of **₱156,785.58** and **₱154,019.86** respectively to be completed in 10 calendar days.
6. For the Project **Repair of Public Restrooms at New PICO Building, Port of Iligan, Iligan City** with the Approved Budget for the Contract of **₱999,850.00**. Bid document of **BRIMA CONSTRUCTION AND ENTERPRISES** and **R. DE MESA CONSTRUCTION** were opened. Each items were read aloud, screen shared and checked against the list of the required documents. Bid proposal documents of the bidders were found to have complied with the minimum requirements and offered the amount of **₱998,398.80** and **₱996,849.80** respectively to be completed in 80 calendar days.

The BAC Chairperson announced that three projects will undergo Evaluation and Post Qualification. Having no more to discuss, the meeting was adjourned at 11:10 A.M.
