



BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL

ONE (1) LOT PROVISION OF FREIGHT SHIPPING SERVICES FOR PPA, PMO-ZAMBOANGA, ZAMBOANGA CITY, FROM AUGUST 1- DECEMBER 31, 2024, WITH AN ABC of ₱60,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the **ONE (1) LOT PROVISION OF FREIGHT SHIPPING SERVICES FOR PPA, PMO-ZAMBOANGA, ZAMBOANGA CITY FROM AUGUST 1- DECEMBER 31, 2024, WITH AN ABC of ₱60,000.00** on July 10 to 16, 2024 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: LBC, JRS Business Corporation and LIBCAP Super Express.

WHEREAS, the BAC opened the sealed price quotation of supplier on July 16, 2024. Out of the three (3) only two (2) submitted their price quotation before the set deadline, namely: LIBCAP Super Express on July 16, 2024, and JRS Express on July 15, 2024. The result were as follows:


