

**UNITS AT THE PORT OF DAPITAN AND PORT OF SINDANGAN** with Approved Budget of the Contract (ABC) through the PPA Corporate Funds the sum of **TWO MILLION ONE HUNDRED THIRTY-FOUR THOUSAND EIGHT HUNDRED SIXTY-SEVEN PESOS & 25/100 (Php 2,134,867.25)**.

The BAC Chairman gave the floor to the BAC Secretariat to acknowledge of attendees, PPCI MELINDA H. CERBITO, *Head Secretariat*, acknowledged the attendees and the prospect bidders who attended the meeting, and after confirmation that majority of the members are present, the Chairperson declared quorum.

The Chairperson ordered for the presentation of the technical aspect of the project, further encourages the prospect bidder present during the meeting to raise question if there are any clarification on the presentation.

CHRISTAN IAN EMPEYNADO, *Secretariat Member* presented the technical aspect of the project; the following are the highlights during the presentation, to wit:

- a. *A complete set of Bidding Documents may be acquired by interested Bidders on August 01-22, 2019 and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00) exclusive of VAT. The Bidder should note that the Procuring Entity will accept bids only from those that have paid the applicable fee for the Bidding Documents at the office indicated in the Invitation to Bid;*
- b. *Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act";*
- c. *Supply, Delivery and Installation of Eight (8) Air Conditioning Units at the Base Port Dapitan and Supply, Delivery and Installation of ~~nine~~ (9) Air Conditioning Units and Six (6) Air Curtain Units at TMO Sindangan should be within four (4) weeks;*
- d. *The following shall be submitted in addition to those specified under section 29.2 of the GCC:*
  - d.1 Latest Income and Business Tax Returns, filed and paid the Electronic Filing and Payments System (EFPS), consisting of the following:
    - 2018 Income Tax Return with proof of payment; and VAT Returns (Form 2550M and 2550Q) or Percentage Tax Returns (2551M) with proof of payment covering the months of January 2019 to June 2019.
  - d.2 In case the PhilGEPS Platinum Registration is not available during bid submission, it shall be submitted as a post qualification requirement in accordance with Section 34.2 of the 2016 Revised IRR of R.A. No. 9184.
