

LOT 2 - ONE (1) LOT –SUPPLY AND DELIVERY OF SUPPLIES AND MATERIALS OF PPA, PMO-ZAMBOANGA

BAC Resolution Declaring the Lowest Calculated and Responsive Quotation, and Recommending Approval

RESOLUTION NO. 14-2015

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga through its Bids and Awards Committee for the Procurement of Goods and Services (BAC-PG) in accordance with Section 52.1 (b)-Shopping of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 advertised/posted the Request for Quotation for the Lot 2- One (1) Lot Supply and Delivery of Supplies and Materials of PPA, PMO-Zamboanga in the PPA Website, PhilGEPS Website, and a conspicuous place at the Bulletin Board of PPA, PMO-Zamboanga from November 9-16, 2015, continuously for seven (7) calendar days;

WHEREAS, from November 9-16, 2015, the Office required the suppliers to submit not later than November 17, 2015 at 2:00 P.M. their quotations enclosed in an envelope with the following documents:

1. Duly accomplished PPA-Prequalification State Form together with the attached documents; and
 1. Valid Current Mayor's Business Permit;
 2. Certificate of Registration of Business Name (DTI/SEC or CDA);
 3. BIR-VAT/Non-VAT Registration Certificate;
 4. Latest Annual Income Tax Return (Annual Income Tax Return-CY 2014); and
 5. Certificate of Philgeps Registration.
2. Duly accomplished Bidder's Tender Form with price quotations indicated therein (sealed).

WHEREAS, the Office required that suppliers should have the complete documents attached to the Bidder's Tender Form sealed in an envelope and quotations received in excess of the ABC shall be automatically rejected. It was also stated that the said lot shall be awarded to the supplier determined to have submitted the complete documents and with lowest calculated and responsive quotation;

WHEREAS, the Members of the BAC-PG together with the Technical Working Group (TWG), the Secretariat, and GSO/Concurrent Procurement Officer attended the meeting during the Opening of Quotations held on November 17, 2015 at 2:00 P.M., at the Conference Room, Administrative Building, PPA, PMO-Zamboanga;

WHEREAS, the Chairperson of the BAC-PG, Emiliano M. Esparaguera, Jr., presided over the meeting and announced the Opening of Quotations for the Lot 2-One (1) Lot Supply and Delivery of Various Supplies and Materials of PPA, PMO-Zamboanga (ABC= P 135,000.00);

WHEREAS, five (5) suppliers responded to the said advertisements, namely: 1) Victorious General Merchandise & Services; 2) Asiatic Trading; 3) Scepter Enterprises; 4) Zamboanga Goodwill Hardware; and 5) Eletriparts Electrical Supply & Service Center;

WHEREAS, from among the five (5) suppliers, only four (4) suppliers submitted their complete eligibility documents. The Chairperson requested the TWG to open the submitted eligibility documents. All of the four (4) suppliers were eligible and determine "passed" with the following price quotations:

4. Asiatic Trading Corporation	P 128,430.00	Fourth Lowest Calculated Bidder

WHEREAS, the BAC members agreed to award the said lot to Scepter Enterprises as the supplier with the Lowest Calculated Quotation;

WHEREAS, upon careful examination, validation and verification of all the documents submitted by Scepter Enterprises, the quotation has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:

- a) To declare Scepter Enterprises as the supplier with the Lowest Calculated and Responsive Quotation in the amount of P 111,310.00;
- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.




