**OUTSOURCING OF TEMPORARY SUPPORT PERSONNEL FOR CY 2016**

**BAC Resolution Declaring Single Calculated and Responsive Bid (LCRB) and  
Recommending Approval**

**RESOLUTION NO. 05-2016**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga advertised the Invitation to Bid of the Outsourcing of Temporary Support Personnel of PMO-Zamboanga for CY 2016 in the Philippine Star on May 11, 2016, a newspaper of nationwide general circulation, and posted the same on May 11-18, 2016, at the Philippine Government Electronic Procurement System (PhilGEPS) Website, PPA Website and conspicuous place at the premises of the Philippine Ports Authority, PMO-Zamboanga;

WHEREAS, in response to the said advertisements, one (1) contractor in the name of LBP Service Corporation (LBPSC) submitted a Letter of Intent (LOI) and purchased the bid documents during the prescribed schedule;

WHEREAS, a Pre-Bid Conference was held on 27 May 2016 at 1:30 P.M. in accordance with and as mandated by Sec. 20 Art. VII of R.A. 9184 and Sec. 20.2 of Rule VII of its Implementing Rules and Regulations.

WHEREAS, during the Pre-Bid Conference, the BAC, upon verification by the participating bidder, clarified that the Tax Clearance required by Sec. 23.1 (a) (iii) for submission to the BAC, must be valid upon opening of the bids.

WHEREAS, during the Opening of Bids held on 9 June 2016 at 1:30 PM, LBP Service Corporation was found compliant with and passed the eligibility requirements as provided under Sec. 23 of Rule VIII of the Revised Rules and regulations of R.A. 9184 with regard to the procurement of goods


WHEREAS, the detailed evaluation of the bids conducted on 10 June 2016 at 1:30 PM, showed that the bid proposal of the herein bidder in the amount of P3, 304,610.88 was lower than the ABC of P3, 305,000.00 for the project, thus, LBP Service Corporation was declared as the Single Calculated Bid;

WHEREAS, the BAC-TWG conducted a post-qualification on the bidder on June 13-15, 2016 as required under Sec. 34, in rel. to Sec. 36, Rule V of the Implementing Rules and Regulations of R.A. 9184, and upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by LBP Service Corporation, the bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare LBP Service Contractor as the Bidder with the Single Calculated and Responsive Bid for the Outsourcing of Temporary Support Personnel of PMO-Zamboanga for CY 2016.
- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga the foregoing findings.
