

ONE (1) LOT – SUPPLY OF MATERIALS, LABOR, AND EQUIPMENT FOR THE PROVISION OF ONE (1) UNIT DIESEL GENERATOR SET, 75 KVA, SILENT TYPE, BRAND NEW, INCLUDING ITS DELIVERY ON SITE AND WIRING INSTALLATION

BAC-PG RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDIG APPROVAL

RESOLUTION NO. 09-2016

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga advertised the Invitation to Bid for the “One (1) Lot – Supply of Materials, Labor, and Equipment for the Provision of One (1) Unit Diesel Generator Set, 75 KVA, Silent Type, Brand New, Including Its Delivery on Site and Wiring Installation,” at the Philippine Government Electronic Procurement System (PhilGEPS) Website, PPA Website and conspicuous place at the premises of the Philippine Ports Authority, PMO-Zamboanga from August 26-September 2, 2016, for seven (7) calendar days;

WHEREAS, in response to the said advertisements, five (5) suppliers submitted their Letter of Intent and purchased the bid documents within the prescribed schedule;

WHEREAS, a Pre-Bid Conference was held on 02 September 2016 at 2:00 PM, Conference Room, Administration Building, PPA, PMO-Zamboanga, Zamboanga City, to solicit issues and concerns from the bidders before the finalization/submission of their Bid documents;

WHEREAS, during the Pre-Bid Conference, an amendment was made on the bid documents particularly on the Section VIII-Bidding Forms, under Letter I. Bill of Quantities of Item 1 from Circuit Breaker #200 Amp., Industrial Type w/ housing, 3 phase to Manual Transfer Switch (MTS) 200 Amp., 3 phase;

WHEREAS, in the Submission/Opening of Bids held on 14 September 2016 at 2:00 PM, Conference Room, Administration Building, PPA, PMO-Zamboanga, Zamboanga City, out of the five (5) suppliers who purchased the bid documents, only four (4) suppliers submitted their bid documents;

WHEREAS, during the opening of bids, it was agreed by the body that the opening of the said documents shall be in alphabetical order. It was also agreed that all the four (4) technical bid envelopes of the four (4) suppliers shall first be opened and scrutinized. Those who will pass in the technical bid and be found eligible, their financial envelope shall then be opened;

WHEREAS, the BAC Chairperson requested the TWG to open the envelopes for technical bid of the four (4) suppliers, namely: 1) Fil Generators & Services Company, Ozamiz City; 2) Fil Power Group & Marketing Corporation, Bacolod City; 3) Megamight Enterprises, Davao City; and 4) Victorious General Merchandise & Services, Zamboanga City;

WHEREAS, after the examination and careful study of all the submitted technical bid of the above-mentioned suppliers, the BAC members found the proposal in accordance with the stipulated standard. The BAC then rated all the four bidders as “PASSED”;

WHEREAS, the BAC Chairperson requested the TWG to open the envelopes for financial bid of the four (4) eligible suppliers as above-mentioned. After the examination and careful study of the financial bid, the BAC members found the proposal in accordance with the stipulated standard. The BAC also rated all the subject four (4) bidders as “PASSED”;

WHEREAS, the result of the opening of the financial bid envelopes that were found to be substantially complying are detailed below:

WHEREAS, based on the above-mentioned ranking of the four (4) suppliers, the BAC members declared Fil Generators & Services Company, Ozamiz City, as the bidder with the Lowest Calculated Bid;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Fil Generators & Services Company, Ozamiz City, the bid has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga the foregoing findings.


