WHEREAS, the Philippine Ports Authority (PPA) PMO SOCSARGEN poste/published the Invitation to Bid for the project Repair and Replacement of Fendering and Mooring System at Calibration 290-410 (Eastern Wharf) and Concrete Curb at Calibration 290-510 (Eastern Wharf), Port of General Santos, General Santos City with an approved budget of Twenty Six Million Seven Hundred Forty Eight Thousand and One Hundred Two Pesos (Ph 26,748,102.00);

WHEREAS, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC-EP on June 09 to 10, 2015;

WHEREAS, the TWG, during the June 15, 2015 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by GRACE CONSTRUCTION CORPORATION;

NOW THEREFORE, We the members of the BAC-EP RESOLVE as it is hereby RESOLVED:

 To declare GRACE CONSTRUCTION CORPORATION as the Single Calculated and Responsive Bidder in the bid price of Twenty Six Million Six Hundred Forty Seven Thousand Two Hundred Twenty Five Pesos and Seventy Eight Centavos (Ph 26,647,225.78); and
